# Quantum Medical Aid Society (QMAS) amalgamating with Discovery Health Medical Scheme

We are pleased to inform you that Quantum Medical Aid Society (QMAS) will be amalgamating with Discovery Health Medical Scheme (DHMS) from 1 August 2021.

## What the amalgamation means

QMAS will be merging with DHMS from 1 August 2021. This means that current QMAS members, including pensioner members and dependents, will be transferred to DHMS effective 1 August 2021 as per the amalgamation terms and conditions.

# **Identifying the new Discovery Health Medical Scheme members**
