



# Strava #MapmyV Competition Terms and Conditions

The purpose of these terms and conditions are to govern Vitality and Team Vitality members and their engagement in the #MapmyV challenge comprising of a run or cycle on from Thursday 9 December to Sunday 13 December 2020.

- 1. The promoters of the competition are Discovery Vitality (Pty) Ltd ("Discovery Vitality") and Strava Inc.
- 2. The competition will run from 9 December 00:01 until 13 December 23:59. The closing date of the competition is 13 December 2020 at 23:59 and is open to all Vitality and Team Vitality members.
- 3. Any activities/entries made before or after these dates will not be considered.
- 4. All Vitality members may participate in the Strava #MapmyV challenge. The terms of Strava #MapmyV competition do not apply to any dependants under the age of 18 (eighteen) years.
- 5. The following will be considered as a valid completion of the Strava#MapmyV fitness challenge for purposes of competition entry:
  - 5.1 Downloading the Strava application and joining the Team Vitality Running and/or Team Vitality Cycling communities on the application.
  - 5.2. Running or cycling the V shape and taking a screenshot of the completed workout on the Strava application.
  - 5.3. Sending the screenshot of the mapped V as well as a photograph of Yourself to TVcompetition@discovery.co.za.
- 6. Only 1 (one) entry will be allowed per member and only 1 (one) prize will be awarded to each winner. Winners will be chosen from either cohort depending on their membership.
- 7. By completing the actions above, Discovery Vitality members stand a chance of winning one (1) of twenty-four (24) prizes on offer from Fitbit, Discovery Athleisure and RunHikeBike.

#### Strava #MapmyV Challenge Terms and Conditions

The purpose of these terms and conditions are to govern Team Vitality and Vitality members and their engagement in the #MapmyV challenge comprising of a run or cycle on from Thursday 10 December to Sunday 13 December 2020.

#### 1. Definitions

In these terms and conditions, the terms below have the following meanings:

- 1.1. "Applicable Laws" means all national, provincial, local and municipal legislation, regulations, statutes, by-laws, consents and/or other laws of any relevant governmental authority and any other instrument having the force of law that may be issued and in force from time to time with regard to or in connection with the activities contemplated under these terms;
- 1.2. "Discovery Platforms" means the set of related web pages under the Discovery domain, including but not limited to the Discovery website, any Vitality page or related content on the Discovery website, the Discovery App and/or official Discovery social media platforms;
- 1.3. "Discovery Vitality, We, Us" means Discovery Vitality (Pty) Limited bearing Registration Number 1999/007736/07, a company duly registered and incorporated in accordance with the company laws of the Republic of South Africa;
- 1.4. "Discovery" means Discovery Limited with Registration Number 1999/07789/06, a public company duly registered and incorporated in terms of the company laws of the Republic South Africa and its subsidiaries;
- 1.5. "Personal Information" has the meaning ascribed to it under the Protection of Personal Information Act 4 or 2013;
- 1.6. "You, Your" refers to the Main Member of the Vitality membership, unless indicated differently;
- 1.7. "Vitality Programme" the programme that Discovery Vitality markets, operates and manages a programme for the benefit of Vitality Members, the rules and benefits of which may change from time to time

- 2.2. Vitality Members in any province can participate in the event.
  - 2.2.1. Anyone may participate in the Strava #MapmyV challenge. Vitality members will earn double Vitality points for completing the challenge. Members will earn 200 speed points for running at an average of 5.5+km/hr or cycling at an average of 10+ km/hr as opposed to the standard of 100 points.
  - 2.2.2. Pregnant women will be awarded double speed points, therefore, being awarded 400 Vitality points.
  - 2.2.3. The terms of Strava #MapmyV challenge do not apply to any dependants under the age of 18 (eighteen) years.
- 2.3. In order to register for the Strava #MapmyV challenge, participants will have to <u>sign up to Strava</u> and join the Team Vitality <u>running</u> or <u>cycling</u> communities on the application.
- 2.4. By registering for the event, you accept the terms and conditions and You acknowledge and consent that your data (name, surname, ID number or passport number and email address) will be shared with Discovery Vitality and authorised third parties for purposes of awarding points.
- 2.5. Participation is free of charge. However, usage of the Strava application may be subject to data charges as determined by your mobile service provider.
- 2.6. By participating in the Strava #MapmyV challenge, You agree to the limits, terms and conditions that Discovery Vitality, our partner network and third parties associated with the programme may share your Personal Information for purposes of administering the benefit, which includes but is not limited to the awarding of points.
- 2.7. You acknowledge that it is Your responsibility to consult a healthcare provider before beginning this or any exercise programme in respect of your past or present injury, illness, health problems or any conditions or medication that may affect Your participation in the programme at any point in time.
- 2.8. You warrant that the relevant medical checks have been completed and that there are no medical restrictions to Your participation in the Programme:
- 2.9. Vitality Members acknowledge this is a Vitality event and Vitality Member's data will be used towards points allocation, and your data will flow via Strava towards this purpose. This is according to the Vitality Main Rules and Strava benefit guide.
- 2.10. Any personal information relating to the participants will be used in accordance with the Protection of Personal Information Act 4 of 2013 ("POPI").

## 3. Engagement

- 3.1. The following will be considered as a valid completion of the Strava #MapmyV fitness challenge for purposes of earning double Vitality points
  - 3.1.1. Linking a qualifying fitness device or smartphone to Strava and the Discovery app so the run or cycle can be verified.





- 3.1.2. Running or cycling the V shape and taking a screenshot of the completed workout on the Strava application on Your mobile device.
- 3.1.3. Sending the screenshot of the mapped V as well as a photograph of Yourself to TVcompetition@discovery.co.za.
- 3.1.4. Members who participate in the challenge and enter into the competition will be entered into a draw to win prizes from Fitbit, Sportsman's Warehouse, RunHikeBike and Discovery Athleisure. This competition is only applicable to the challenge for the period of 9 December to 13 December 2020. T&C's apply.
- 4. Photographs will be subject to a screening process before being accepted to be publically displayed on mosaics across Discovery's social media platforms.
- 5. Any transgressions of the rules of the Vitality Online workout programme and / or misuse of the programme by you shall be subject to the conditions as set out in the Vitality Main Rules or the Main Rules governing ancillary programmes, whichever is applicable to you.
- 7. Discovery Vitality encourages honest and accurate logging of workout sessions and will conduct random audits to check the validity of the events that Members log. It is your duty to ensure that your engagement in the programme is free from any fraudulent activity.
- 8. By accepting these terms and condition when you activate and engage in workout, You consent to Discovery Vitality processing your Personal Information for the purposes of administering the programme. You consent to Discovery Vitality sharing and procuring your Personal Information with and from contracted third parties, only insofar as it relates to the administration of the programme, who may require such information in order to render a service to You and only if such contracted third party agrees to keep the information confidential.
- 9. Data costs may apply as a result of engagement in the programme. Discovery Vitality shall not be liable for any data costs that may associated with your engagement in the programme as well as your internet connection, this remains the responsibility of the Member.
- 10. The following will apply to member's engagement in the Strava#MapmyV fitness challenge:
  - 9.1. The Vitality main rules apply at all times;
  - 9.2. The exercises and advice presented in the programme are in no way intended as a substitute for medical consultation.
