

## INSTRUCTIONS ON COMPLETING THE PROXY APPOINTMENT FORM

- 1. If you are unable to attend the Discovery Health Medical Scheme ("DHMS/Scheme") Special General Meeting ("SGM"), you are able to nominate a proxy (another Principal Member authorised to attend, speak and vote on your behalf) by completing the Proxy Appointment Form ("Proxy Form").
- 2. The Rules of the Scheme specify that the proxy (another Principal Member authorised to act on your behalf) must be a Principal Member of the Scheme and must attend the SGM.
- 3. Only Principal Members in good standing (contributions not in arrears) may appoint other Principal Members who must also be in good standing, as proxies.
- 4. Each Proxy Form must be signed by both the Principal Member appointing the proxy and the Principal Member appointed as the proxy.
- 5. Please note that each Proxy Form has unique security features. Only Proxy Forms issued to a particular Principal Member can be used by such a Principal Member.
- 6. No deletions/corrections to the proxy form will be accepted and will be considered "spoilt". If the Proxy Form is spoilt for some reason, the member shall be obliged to contact PricewaterhouseCoopers Advisory Services (Pty) Ltd ("PwC") to request a new Proxy Form by contacting **012 429 0505** or emailing **DHMSSGM2017@za.PwC.com** and the old Proxy Form shall be deemed to be null and void.
- 7. All information required on the Proxy Form must be completed and signed by both parties (the Principal Member appointing the proxy and the Principal Member appointed as proxy). Failure to do so may invalidate the Proxy Form.
- 8. PwC shall screen the completed Proxy Forms and shall determine their validity. PwC's decision will be final and binding.
- 9. Completed and signed Proxy Forms must reach PwC by no later than 09:00 on 04 September 2017. Any Proxy Forms received after this date and time will be deemed to be invalid.

## NOTES TO THE PROXY FORM

1. To be valid, the Proxy Form must be lodged with PwC by no later than 09:00 on 04 September 2017. The completion and lodging of this Proxy Form will not preclude the relevant Principal Member from attending the SGM and voting in person instead of any proxy appointed in terms hereof. Should the Principal Member attend or vote at the meeting, the proxy that has been appointed will not be able to vote on the Principal Member's behalf and the proxy shall be deemed to have been revoked.
