

## Terms and conditions for the Vitality Ster-Kinekor Wicked Part 1 competition

1. The promoters of the competition are Discovery Vitality (Pty) Ltd ("Vitality") and Ster-Kinekor Theatres (Pty) Ltd ("Ster-Kinekor").
2. The competition will run from **28 October – 10 November 2024**, with a deadline for entry at midnight on 10 November 2024 ("Competition Period").
3. Participants of the competition are required to reside in South Africa
  - 3.1 Participants of the competition are required to reside in Johannesburg, and/or Cape Town and/or Durban as the prizes are redeemable in these areas only.
4. The competition is open to qualifying Discovery Vitality Health and Vitality Active members who activate their Vitality Ster-Kinekor movie benefit within the Competition Period.
5. Entrants need to be the main member, spouse, adult dependants, or child dependants over the age of 18 (eighteen) years on the Vitality membership.
