

Terms and conditions for the Discovery Vitality Padel May social media campaign

1. The promoter of the competition is Discovery Vitality (Pty) Ltd (“Vitality”).
2. The competition will run from **1 – 31 May 2026** with a deadline for entry at midnight on **31 May 2026**.
3. Vitality members who are 18 years or older and residing in South Africa are eligible to participate in the competition.
4. This competition is exclusive to the Vitality [Facebook](#) and [X social media](#) pages.
5. Eligible participants and their three friends (who don't have to be Discovery Vitality members) can stand a chance to win:
 - a. A padel experience, which includes a two-hour padel session at a padel facility selected by you, from our Vitality Padel network.
 - b. Rental of padel equipment for the day from the selected padel facility.
 - c. Light snacks and refreshments to the value of R300 per person.
 - d. A goodie bag
 - e. The prizes need to be redeemed by November 2026.
6. To participate in the competition, participants need to activate the Discovery Vitality Padel benefit and book a padel court at one of the padel facilities in the Discovery Vitality Padel network on the Playtomic app during the competition period (1 – 31 May 2026).
7. Participants need to comment on the specific Vitality's [Facebook](#) or [X](#) social media post tagging or mentioning the facility within the Discovery Vitality Padel network where they played and include the hashtag #DiscoveryVitalityPadel.
 - a. The use of all the above-mentioned hashtags is mandatory for the entry to be considered. Failure to include all hashtags will render the participant ineligible for the competition.
 - b. Any activities done before or after the above-mentioned dates will not be considered.

- c. Each participant is entitled to one entry per court booking for the prize draw, regardless of the number of comments they have made or if they have commented on both the Vitality Facebook and X social media page.
8. Participants will only have one entry into the prize draw regardless of the amount of court bookings made during the month of May.
 9. Cancelled bookings will not be considered as entries into the competition.
 10. After the closing date, all eligible participants will be entered into the random draw where one winner will be chosen.
 - a. The prize winners will be drawn randomly from the qualifying entries by Discovery Vitality and will be contacted from 5 June 2026. The winners will be contacted through a direct message on Facebook or X requesting their ID numbers and a screenshot of their booking on the Playtomic app. If the selected winner does not provide their details within 3 business days (72 hours), an alternative winner will be chosen.
 - b. The prize is only applicable to padel courts within the Discovery Vitality Padel network.
 - c. Bookings are subject to availability and the selected padel facility's terms and conditions.
 11. The participants may be required to appear and be identified on the Vitality social media pages at no fee to them. The awarded participants can decline the option of appearing or being mentioned on the Vitality social media pages and will not forfeit the prize.
 12. The prize cannot be exchanged or transferred.
 13. Any violation or attempt to violate any of the rules will result in immediate disqualification of the transgressor.
